Said applicant hereby agrees that applicant will conform to and be bound by the original Service Agreement and the Easement, each of which are part of this document.

All transfers of membership certificates shall be made upon the books of the rural water district upon the surrender of the certificates covering the same by the holders thereof, or by their legal representatives. But only with the approval of the Board of Directors and only to persons free from indebtedness to the rural water district.

The undersigned hereby makes application for membership transfer in the said rural water district and agrees to the following conditions:

Pay a minimum monthly charge to be established by the Board of Directors, beginning from the time service is made available by the district, and pay for additional water used at the rate set out in the rate schedule adopted by the Board of Directors. Any changes adopted, for the minimum monthly water charge and the rate schedule, by the Board of Directors of the rural water district shall become a part of this agreement as though fully set out herein.

All water shall be metered by meters furnished and installed by the rural water district.

If, after water service is made available, the same is discontinued or disconnected for any purpose, pursuant to the Bylaws and the Rules and Regulations of the rural water district, reconnection shall be upon the conditions set out in the Bylaws and the Rules and Regulations of the Rural Water District.

The laws of the State of Oklahoma, the Bylaws of the Rural Water District and the Rules and Regulations of the Rural Water District, as presently existing, and as may be amended from time to time are made a part of this Agreement as though fully set herein.

The member shall hold the rural water district harmless from any and all claims or demands for damage to real or personal property occurring from the point member connects to the rural water district meter to the final destination of the line installed by the member. The member agrees to grant to the rural water district an easement or right-of-way for the purpose of installing, maintaining and operating such pipelines, meters, valves, and any other equipment which may be deemed necessary by the rural water district.

The rural water district shall have the right to locate a water service meter and the pipe necessary to connect the meter on the property of the member at a point to be chosen by the rural water district, and shall have access to its property and equipment located upon the member's premises at all times for any purpose connected with, or in the furtherance of its business operations, and on discontinuance of service shall have the right to remove any of its property from the member's premises.

EASEMENT

The undersigned, for the location of the existing or the relocation of meter do hereby and convey unto Okmulgee County Rural water District No. 20, a permanent easement twenty (20) feet wide, on property described as follows: (please fill in property legal description).

For the purpose of constructing and maintaining, repairing, removing, relaying and replacing fresh water line on and over, or buried within, the above described land, as may be necessary from time to time, with right of ingress and egress, TO HAVE AND TO HOLD the same unto the granted, its successors and assigns forever. Should the grantee abandon the above property for the purposes above stated, then the said easement shall revert to the grantor or grantor's successor in interest.
